## EQUAL EMPLOYMENT OPPORTUNITY POLICY STATEMENT

Further, Tempus will not discharge or in any other manner discriminate against employees or applicants because they have inquired about, discussed, or disclosed their own pay or the pay of another employee or applicant.

As Chief Legal and Administrative Officer of Tempus, I am committed to the principles of Affirmative Action and Equal Employment Opportunity.
